## March 29th Deadline Pride of Place Awards Nominations Sought:

Clare County Council invites expressions of interest from local communities, projects or housing estates who wish to seek nomination to the IPB Pride of Place 2018 in association with Co-operation Ireland. This annual All-island competition, which is run in conjunction with local authorities North and South, aims to recognise and celebrate the vital contributions that communities make to society along with generating awareness, respect and inclusion for every facet of society. All applicants will be informed by end of April as to whether they have been nominated to compete at All-island level. If they have been nominated they will be visited for adjudication over 2 - 3 hours, one day, in the months June to August.

Clare County Council may nominate one group only per category and a maximum of 5 groups overall.

The following categories apply: -

Population Category 1 up to 300 people

Population Category 2 between 300 to 1000 people

Population Category 3 between 1000 to 2000 people

Population Category 4 between 2,000 to 5,000 people

Population Category 5 over 5,000 people

Category 6 Theme Category "Creative Place Initiative"

Category 7 Theme Category "Community Wellbeing Initiative"

Category 8 Theme Category "Community Tourism Initiative"

Category 9 Housing Estates (not population specific)

Category 10 Islands and Coastal Communities (not population specific)

Category 11 Urban Neighbourhoods (not population specific)\*

The Expressions of Interest will be assessed, per category, based on the Co-Operation Ireland criteria available on request from this office and at www.prideofplace.ie. Community group winners, runners up and special award recipients receive a trophy and small monetary prize at a special awards ceremony, which will be hosted in Cork City, in November. Groups interested in being considered for nomination are asked to submit a written expression of interest, detailing their preferred Category with a one page typed summary (no more than 150 words) setting out their proposal to:

### March 16th Shannon Municipal District Grants Deadline this Friday!

Clare County Council is inviting applications from community groups in the Shannon Municipal District to the 2018 Community Grants Scheme before the deadline of 16 March 2018. The €41,500 scheme aims to support community groups engaged in a wide range of cultural, artistic, heritage, sporting, educational and community work. Cathaoirleach of the Municipal District, Cllr. Mike McKee said, "This is the third such grants scheme for the Shannon Municipal District and I have no doubt that this one also will be taken up widely within the District by community organisations".

"The scheme is used mainly to encourage existing groups to develop and enhance their current activities, whilst also encouraging them to develop new and innovative ideas. The scheme is now open for applications from community groups for projects and special initiatives they are undertaking in 2018," he added. #### **Voice Ireland New Community Grant**

Small Grants available to communities who want to raise awareness about recycling - VOICE and Repak have developed this grant to support community groups to engage with their neighbours to clear up the confusion around recycling through local face-to-face discussions, and to help with research into

The Grant may be used for a specific sustainability focused project to take place between May-July 2018. ## March 16<sup>th</sup> Deadline - Social Inclusion Consultation

The National Action Plan for Social Inclusion 2007-2016 (NAPinclusion), identified a wide range of targeted actions and interventions to support the overall objective of achieving the National Social Target for Poverty Reduction (NSTPR). The Plan adopted a life-cycle approach with goals set for each group: children; people of working age; older people, people with disabilities and communities.

The Plan was updated for the period 2015 - 2017 to reflect the current issues and interventions to tackle poverty. There was a greater focus on modernising the social protection system, improving effectiveness and efficiency of social transfers and strengthening active inclusion policies. The Updated Plan contained 14 reformulated goals which include a focus on early childhood development, youth exclusion, access to the labour market including measures for people with disabilities, migrant integration, social housing and affordable energy.

The Programme for Partnership Government includes a commitment to develop a new Integrated Framework for Social Inclusion, to tackle inequality and poverty.
