## Open Government Partnership:Civic Forums and Call for Submissions

The Open Government Partnership (OGP) is an initiative of 70 countries including Ireland. It aims to secure concrete commitments from governments to promote transparency, empower citizens, fight corruption, and harness new technologies to strengthen governance. It is run by a steering committee composed of governments and civil society organisations.

If you have any views or good ideas on how any of our government institutions or the government itself can serve the population better you should participate in the this consultation. The Department of Expenditure and Government Reform will be using the results of this process to inform their National Action Plan on Open Government 2016- 2018.

You can get involved in the current consultation on **Ireland's Second National Action Plan on Open Government** by making an open submission and then taking the opportunity to discuss your views further at a civic forum.


