Voter registration day

Clare Public Participation Network, Clare County Council and the Garda Siochana Clare Division are collaborating to organise a Voter Registration 'One-Stop-Shop' for people who wish to register for a vote in the forthcoming referendum on the Eighth Amendment. The referendum will be held on Friday, 25 May 2018 and those who are not registered to vote have until May 8th to apply to be included on the Supplementary Register which will enable them to cast their vote.

The One Stop Shop will take place in Clare County Council on May 3rd from 11 am until 3pm and Clare residents wishing to register to vote should attend during those hours and bring an official form of photo ID (Passport, Driving Licence etc) They will be assisted by volunteers from Clare PPN as well as the Gardai and Clare County Council Staff in completing their application there and then. Clare PPN advise everyone even those who have voted before to take a moment or two to make sure they are still on the register and that their details are correct.
