### **Draft Climate Change Adaptation Strategy Consultation Closing Date August 9th 2019**

Clare County Council have prepared a **Draft Climate Change Adaptation Strategy** and they are currently seeking your views on it. The deadline for submissions is August 9<sup>th</sup> 2019 and all details are at this link:

Because this is important for all of our environmental groups we are going to hold a focus group-get together on July 29<sup>th</sup> from 6.30 – 9.30 in Clare PPN's offices, Clonroad Business Park, Ennis. This will be a working meeting at which we will work on Submissions for the Draft Climate Change Adaptation Strategy, we will discuss the forthcoming elections which we must hold for environmental seats on Clare County Council's Policy Committees and we hope to have a discussion about the Clare Environmental Network and how Clare PPN can better support its environmental college in the years to come. #### **Draft Scheme for Strategic Policy Committees**

Bear with me, this one is complicated! Clare County Council has prepared a new 'Draft Scheme for Strategic Policy Committees' what this is really is the rules for the set up and operation of committees which include both elected Councillors and outside interest such as business, farmers organisations, trade unions and yes you've guessed it – Community Representatives elected through Clare PPN. The closing date for submission to this draft scheme will be late August 2019 but as yet we have no details of the closing date or the process for making submissions. For those of you new to Clare PPN – the reason that this draft scheme is important is that we have between one and three representatives sitting on each of 4 of these committees and their role is to bring the expertise and experience of the Community and Voluntary sector in Clare to bear on the work of Clare County Council.

We will hold a meeting in mid-August to explain what the role of a representative is and what positions are on offer and we can go through the draft scheme then but for the moment we are notifying you that the draft scheme has been published.

#### **Local Property Tax Rate Adjustment Consultation**

Clare County Council will meet in September 2019 to consider the setting of local adjustment factor on Property Tax rate. Clare County Council welcomes submissions from the public on this matter, specifically ones which cover the potential effects of varying the basic rate of the Local Property Tax on businesses, individuals and local authority services. Submissions must be received by 29<sup>th</sup> July 2019. #### ESB Community Groups Funding Next Quarterly Deadline for Applications September 6th

ESB's Energy for Generations Fund sees over €2m per year disbursed across a range of community and issues-based initiatives. Each year the Fund awards €1m in direct funding through a quarterly fund to charities working in the areas of suicide prevention, homelessness and education access and support.

ESB has been supporting initiatives in the areas of suicide prevention and homelessness since 2005. The Energy for Generations Fund introduced a new focus on education in 2014, which recognises the need for educational supports at all levels to ensure that Ireland has the skills it needs to compete effectively in the future.

The remainder is allocated across a range of initiatives including support for ElectricAid, wind farm community funds, fuel poverty programmes and support for staff volunteering.

The average grant awarded – is €6-7,000 per application. For more details check out the ESB's website here

Clare County Council and the Limerick and Clare Education and Training Board are providing a free unique 12-week heritage course "Reading Your Landscape" in East Clare which will run every Monday from 16<sup>th</sup> September 2019 to December 2019. This course may be of interest to local heritage/history/tourism groups, landowners, CE schemes, Men's Shed and other interested individuals. This course will enable participants to identify, examine and record the heritage features of their own local area through a combination of field work and desk research. It includes an introduction to geology, biodiversity, archaeology and natural heritage of O'Briensbridge, Bridgetown, Kilbana, Broadford, Parteen, Ardnacrushna and Clonlara.
