FUNDING OPPORTUNITIES

Transport funding for community groups

Funding for community organisations providing meals on wheels, mobility services and cancer care transport is available under Measure 3 of CLÁR, from the Department of Rural and Community Development. CLÁR provides funding for small-scale infrastructural projects in rural areas that have suffered significant population decline, and have been tailored to help rural communities respond to COVID-19.

Organisations will be supported to purchase kitchen or food delivery equipment. They can also access funds for any adaptations that may be necessary to their existing vehicles as a result of new public health guidelines. The deadline for applications is 28th August, 2020. Rethink Ireland - Equality Fund 2020

The Rethink Ireland Equality Fund 2020 can provide cash grants of between €55,000 and €75,000 a year for three years. You can apply under one of these three themes:

- 1. Empowering Women projects that empower more women from minority communities into employment, or women in low paying jobs, or women who find it difficult to assert their rights.
- 2. Strengthening Communities projects that empower communities to advocate for themselves.
- 3. Building Equality Together two or more organisations who have come together to promote equality.

Restart grant to help small businesses reopen

The Government has agreed a Restart grant to help micro and small businesses with the costs of reopening and re-employing workers following COVID-19 closures. The grants will be equivalent to the rates bill of the business in 2019, with a minimum of €2,000 and a maximum of €10,000.
