FUNDING OPPORTUNITIES

Covid-19 Emergency Fund Round 2 - Deadline 7th February



Applications are now open for Round 2 of the Covid-19 Emergency Fund, with total funding of €49,351 available for Co Clare. The fund, which is available to community and voluntary groups for small projects, is provided by the Dept of Rural and Community Development and administered locally by the Local Community Development Committee (LCDC). The grants are aimed at assisting participation in the Government's 'Keep Well' campaign, in particular with the three themes: staying connected, switching off and being creative, and minding your mood. Community Supports Scheme – Deadline 29th January

Clare County Council's Community Support Scheme is available to community and voluntary groups to undertake specific projects. The purpose of the scheme is to encourage and assist community and voluntary groups to take an active part in the development of their communities and to improve the quality of life experience in their areas. Community Water Development Fund – Deadline 9th February



Grants of between €500 and €25,000 are available under the Community Water Development Fund for 2021, open to all community and voluntary groups. Administered by the Local Authority Waters Programme (LAWPRO), the fund supports communities to deliver local projects to address water quality, biodiversity loss and climate change. Projects can include: 1. Capital projects; 2. Awareness raising and information initiatives; and 3. Community benefit and amenity type projects. 2021 Wind Farm Community Funds – Deadline 5th March

The 2021 Wind Farm Community Funds are now open for applications. The fund is available to community and voluntary groups and will prioritise projects and initiatives that support and benefit the areas surrounding ESB owned/co-owned wind farms, including Moneypoint Wind Farm. The categories include education, skills, health and wellbeing, environment and habitat conservation, energy efficiency, culture, heritage, sport, social inclusion and Covid-19 related supports.

Irish Hospice Foundation Seed Grant Scheme – Deadline 29th January

The Irish Hospice Foundation's Seed Grant Scheme aims to inspire and support creative responses to the themes of dying, death and bereavement during the pandemic. The scheme is a partnership with the Creative Ireland programme, and awards are in the region of €500 - €1,000. The grants will support organisations and individuals in exploring creative initiatives to reflect and remember. This may take the form of new local art projects, or to support existing projects - this may involve artists, crafts people or coders. Conservation Grants 2021 – Deadline 22nd January

Minister Malcolm Noonan recently announced funding of €6 million under the Built Heritage Investment Scheme and the Historic Structures Fund for 2021. Managed by the Planning Department of Clare County Council, Stream 1 offers grants from €15k to €50k aimed at essential repairs and smaller capital works. Stream 2 will offer a small number of grants from €50,000 to €200,000 for larger enhancement, refurbishment or reuse projects involving heritage structures; and Stream 3 is a pilot scheme for Vernacular Structures. The closing date is 22nd January, and full details of both schemes are here:

Citizens’ Jury on Access to Health Information

Would you consider joining a Citizens' Jury to discuss the issue of access to health information? The jury will consider whether our health records should be used only for our individual needs or whether they should be made available for wider societal healthcare needs. The Irish Platform for Patients' Organisations, Science & Industry (IPPOSI) is assembling 25 independent-minded people, aged over 18 and living in Ireland, who are broadly representative of Ireland's population. Electoral Reform Bill to bring big changes

Heads of Bill have been published for the Electoral Reform Bill, which will bring major changes to Ireland's electoral law. These include stricter rules around political ads on social media, a new independent Electoral Commission and the modernising of voter registration. The Bill will also facilitate the holding of elections under Covid-19 restrictions. Changes to the Electoral Register include provisional registration for 16-17 year-olds which would become active on their 18th birthday. Political ads on social media platforms will have to be clearly labelled, including details of who paid for them and any micro-targeting.
