




PPN NEWS



Andrew St. Ledger

In our last quarterly report, we were delighted to welcome Andrew St. Ledger back into a representative role in Clare PPN but this delight was short-lived as we heard about his sudden and very untimely death. We are grateful for his expertise and his profound dedication to trees and our environment and we send our sincere condolences to his family and everyone who knew him. Andrew had just taken on the role of Clare PPN's representative on the new Biodiversity and Heritage Forum and he previously represented Clare PPN on the Physical Development SPC.

Andrew worked on biodiversity for more than 20 years, was co-founder of the Woodland League and was involved with environmental organisation CELT. He also had a keen interest in traditional woodcrafts, nature restoration and built heritage, especially traditional vernacular style preservation. CELT honoured his memory with a message describing him as "a mighty Irish environmentalist who will be greatly missed - now a true Spirit of the Woods."



Completion of LECP Research and training pilot project on Just Transition and Socio-Economic Rights in Clare

This six-month pilot project was led by Clare Public Participation Network (Clare PPN) in collaboration with Clare County Council, Limerick and Clare Education and Training Board, and Clare Local Development Company and was funded by the Department of Rural and Community Development from the Dormant Accounts Fund. The research component of this project was conducted by the Thinktank for Action on Social Change (TASC). TASC, who with the valuable expertise of independent facilitator Kathryn McCabe and alongside Clare PPN, held nine focus groups and five public introductory training workshops across the county during the summer of 2023. The findings from this project were submitted to the Draft Local Economic and Community Plan 2023- 2029 (LECP). Clare PPN representatives were also on Clare County Council's LECP steering group which guided the document through its various stages.

Launch of 'Fair Clare'

After extensive consultation and research 'Fair Clare – Securing socioeconomic rights & a just transition in County Clare' was launched in November to a packed house. The long-awaited publication was greeted with huge interest and discussion (so much so that the plenary meeting that was supposed to follow the launch was postponed to a later date).

This report aims to examine the impact of the ongoing transition to zero emissions on groups who experience one or many forms of structural disadvantage in County Clare. Underpinned by a human rights-based approach, focusing specifically on realising the socio-economic rights of Clare residents, the report makes recommendations and contributes to the discussion of how Just Transition planning and policy in Clare can begin to address underlying inequalities and ensure that those who experience poverty, as well as the most marginalised in society, are protected and benefit from the transition.

Clare PPN's community engagement project, to ensure that policies reflecting the lives of the diverse communities in Clare who experience poverty and other forms of discrimination are included in Clare County Council's Local Economic & Community Plan, was included as a case study in the Department of Rural and Community Development's 2nd edition of 'A Guide for Community Engagement in Local Planning & Decision Making. At the launch in Dublin in November, Clare PPN Co-ordinator Sarah Clancy presented key transferrable skills learned throughout the project and Secretariat member Padraic Hayes was part of a panel discussion on the importance of marginalised voices in policy and decision making. 


